



## Head Golf Professional Opportunity at Hillcrest Golf Club

**The Club and Community:** Hillcrest Golf Club is a public golf course located in the mountain town of Durango in Southwest Colorado. Our 18 hole course will soon celebrate its 50<sup>th</sup> year of operation, and is located on a mesa overlooking the town's river valley with views of the nearby La Plata Mountains. The length of the season varies depending upon the length of the winter, but is generally open in mid-March and closes in early November. The course is managed by a non-profit 501(c)4 corporation's board of directors.

Durango is the home of Fort Lewis College and offers a myriad of outdoor recreational activities that attract both visitors and newcomers for rafting, hunting, fishing, skiing, mountain and road biking, hiking and rock climbing. Tourists are also attracted to the area's many historic and cultural destinations. Durango sits at an elevation of 6,512 feet and enjoys nearly 250 playable days. The area features high-quality public schools and charter schools, a vibrant arts, music, and performance community, with strong economic sectors in tourism, medicine, construction, recreation, education, and a growing manufacturing base. Our new Head Golf Professional will have the responsibility for the overall management of the golf shop and outside operations. He or she will be is a full-time, salaried, exempt, at-will employee, expected to be on-site six days per week from March through October, and remain on-call when not on-site. November through February can include a relaxed work schedule, with opportunities for indoor lessons, club fitting, and merchandise sales.

He or she will have three to five years successful experience as a Head Golf Professional, with excellent professional references and previous supervision of food and beverage operations.
